When I was recently asked, “Are the children worse than they ever used to be?” I had to pause and carefully consider my response. The word “worse” can sometimes imply that children are more dangerous, more delinquent, or more criminogenic. That is not how we view the children we serve.

What we are experiencing is a significant increase in youth presenting complex trauma, severe mental health needs, and behavioral challenges that require a higher level of intervention and support. These children are not “worse”; they have often endured significant abuse, neglect, and trauma, and we are serving youth during a very different period in the field of behavioral health and residential treatment.

At Gibault, we have witnessed an increase in the complexity and intensity of the needs of the youth entering our programs. This includes increases in:

- Property destruction and significant behavioral incidents
- Peer-on-peer aggression
- Aggression toward staff
- Emergency room visits for crisis stabilization
- Suicidal ideation and safety concerns
- The need for increased supervision and specialized safety precautions
- Transfers to acute psychiatric stabilization services outside of Gibault

When asked if we have data demonstrating this increase, my response is that we have extensive internal data documenting these trends. However, I also believe one of the strongest indicators can be found by examining the state’s own placement and authorization processes.

Several years ago, the Indiana Department of Child Services implemented a requirement that youth placed in Gibault’s Private Secure Program must undergo a prior authorization process through Medicaid to determine whether they meet criteria for Psychiatric Residential Treatment Facility (PRTF) services.

PRTF eligibility requires significant clinical indicators, including one or more qualifying mental health diagnoses, a history of acute psychiatric needs, psychiatric recommendation, and other documented treatment requirements.

When this process was first implemented, many youth placed by DCS did not meet the criteria required for PRTF services. Today, nearly every DCS youth placed with Gibault meets the criteria and qualifies for Gibault Psychiatric Residential Treatment. In my opinion, this is one of the clearest indicators that the level of clinical acuity among youth entering residential treatment has increased.

Over the past several years, Gibault has continued to respond to these challenges by remaining committed to innovation, evidence-based treatment practices, comprehensive staff training, and adherence to state and federal regulations. We recognize that meeting the needs of today’s youth requires us to continually evaluate and strengthen the way we provide care.

This work is incredibly difficult, but I am continually grateful for the dedicated professionals who choose to do it every day. They are compassionate, resilient, and committed individuals who believe in the potential of every child we serve. We appreciate your continued support of our mission to provide hope, healing, and opportunities to vulnerable children and families.

We welcome the opportunity to share more about our work and invite you to visit our campus, meet our youth and staff, and see firsthand how lives are being transformed at Gibault.

Gibault was founded in 1921 to serve our troubled children, which continues to be very challenging and important work. Many children at Gibault have experienced complex trauma; including physical, sexual, verbal and emotional abuse, as well as neglect.

The Indiana Knights of Columbus worked together to establish Gibault. Working together we continue our commitment to Indiana children. Working together in Unity and Charity is a critical part of our Knights of Columbus mission.

We have an opportunity once again to bring joy to the lives of young people. It shouldn't hurt to be a child.

Please join me in supporting the latest Gibault initiative. Pickleball!

The daily operation of the Gibault campus takes a toll on the facilities, and upgrades are needed. This year the focus is on constructing new pickleball courts on the Terre Haute Campus. Playing pickleball can help our kids with building teamwork and communication skills, teaching sportsmanship, and fostering friendships. It can also boost self-confidence, enhance focus, release energy, and reduce stress. It presents challenges and opportunities for growth. On the court, children encounter obstacles and setbacks that contribute to the development of resilience and perseverance. Accessibility is one great advantage to pickleball and can be enjoyed by children of all ages and abilities, including those who have physical limitations!

This is a multi-phase project. Phase one is to install two courts in the open recreation area outside of Holy Cross Hall with black acrylic resurface over the new pavement and paint the playing areas in standard colors. The first goal is to raise \$106,000 to get the project started.

Phase two will construct an 8 ft. black vinyl chain-link fence with one gate around the court which will cost \$30,000. And phase three will fill cracks and seal the existing basketball courts that share the area as the new pickleball courts. The estimated cost of this phase will be \$8,000.

This is an extremely large undertaking; the total cost of the project estimated at \$144,000.

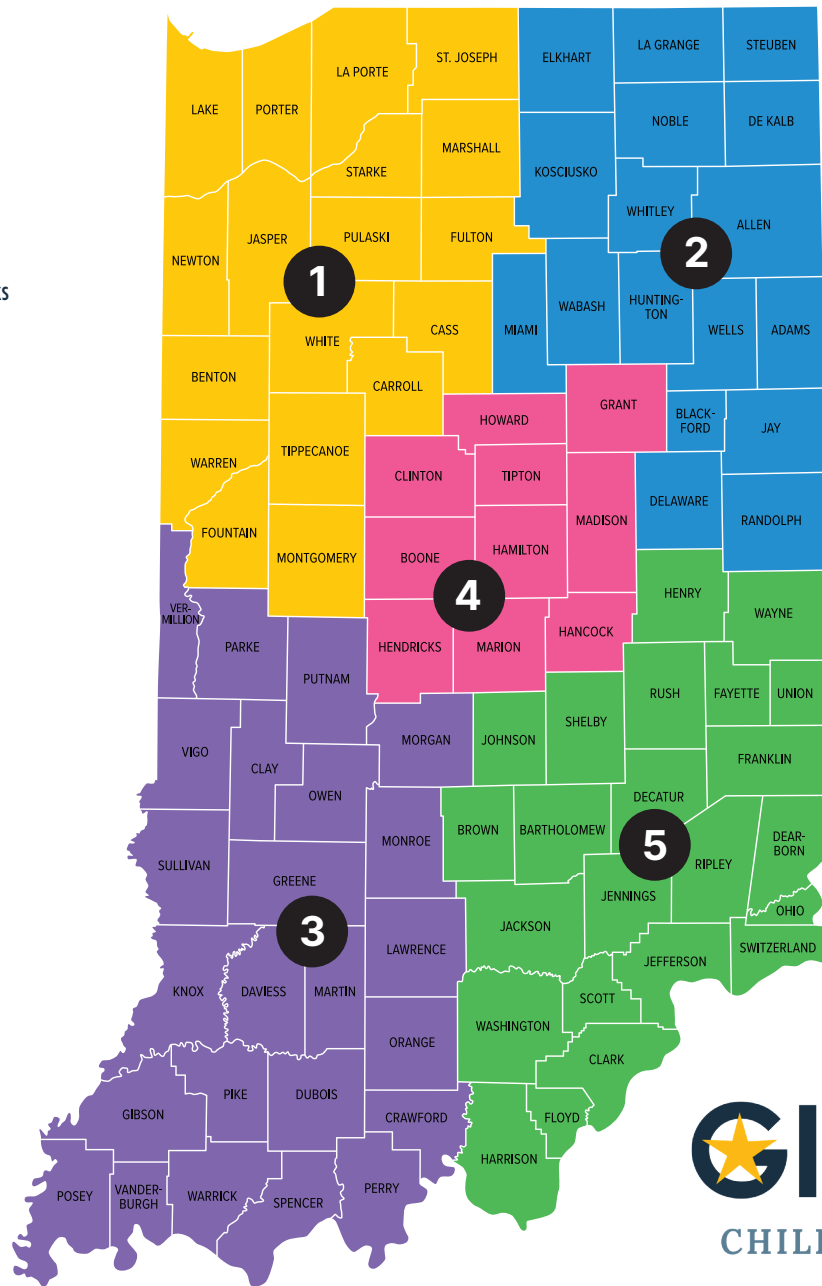
